THIS MATTER came before the Commissioner of Banks on April 13, 2005.

IT APPEARING TO THE COMMISSIONER THAT:

1. This contested case was commenced by Notice of Hearing dated February 1, 2005, and service was accepted by counsel for AANC on February 7, 2005; and
2. The Notice of Hearing set the case to be heard April 19, 2005; and
3. Subsequent to the service of the Notice of Hearing, motions to intervene were made by the Attorney General and by certain persons who are plaintiffs in a civil suit against AANC; and
4. Counsel for AANC filed on March 2, 2005, a Motion to Reschedule Hearing and Response to Intervention Motion; and
5. In response to that Motion to Reschedule, the Commissioner granted an extension of time until March 11 for counsel for AANC to respond to the intervention motions, but the Commissioner held open the rescheduling of the hearing; and
6. It appears to the Commissioner that the hearing of evidence in the case cannot reasonably commence on April 19, and that certain preliminary motions and

arguments as to discovery motions and proposed stipulations of fact should be addressed first;

IT IS, THEREFORE, ORDERED that the hearing in this case is continued to Tuesday, April 26, 2005 at 10:00 AM.
